AFFILIATE AGREEMENT

January 31, 1985 to January 31, 1986

In accordance with action taken by the National Board of Directors in October 1984 and March 1985, all chapters must agree to the following to remain affiliated with the Cult Awareness Network of Citizens Freedom Foundation.

- 1. We agree to supply information on the HARMFUL PRACTICES of DESTRUCTIVE groups and agree not to judge doctrine or beliefs.
- 2. We agree to offer support to all those affected by destructive groups.
- 3. We agree to incorporate the Cult Awareness Network of Citizens Freedom Foundation into our name and indicate clearly our National Affiliate status in our literature and presentations.
- 4. We agree to take a non-denominational approach in our presentations, interviews and publications.
- 5. We agree to abide by the by-laws, be guided by the CAN-CFF positions and stress the positive aspects of CAN-CFF in all talks and publications. CAN-CFF is a non-profit educational and support network concerned about preventing the loss of freedom through deception and manipulation.
- 6. We agree to support CAN-CFF National through the affiliate assessment of \$100.00 per year. Affiliates with 5 or less member/families may satisfy this requirement by generating a minimum of 5 newsletter subscriptions.
- 7. Our affiliate agrees to pay National annual dues of \$25 for each member/family. We agree to support the establishment of the different levels of membership and understand those donating more than \$50 per year will receive special recognition by the National Board of Directors. All members will receive the National Newsletter. Memberships: Patron Member - \$1000 per year, Sponsor Member - \$500 per year, Sustaining Member - \$100 per year, Contributing Member - \$50 per year, Subscriber Member - \$25 per year.
- 8. Exit counseling/deprogramming is a process whereby a member of a destructive group is given the opportunity to restore critical thinking, freedom of choice and freedom of association in order to make an INFORMED and VOLUNTARY decision regarding his/her group affiliation. CAN-CFF is in favor of, and vigorously supports, all legal efforts to restore individuals to freedom of action and choice.
- 9. We agree to send this affiliate agreement, the affiliate assessment and a list of our affiliate's member/families to National by January 31 of each year. We agree to send a quarterly report of our activities to National on March 31, June 30, September 30, and December 31.
